



With reference to the subject cited above we wish to bring to your kind consideration the following facts;

- 1) In the letter issued from your office shown in ref.(1)(Pls see Annexure-I) we observed that the VTU Intake is mentioned as 120 to the computer Science & Engg-UG of our Institute shown in Sl.No. 10. The Computer Science Engg-UG branch of our Institute Intake has been increased to 180 as per the Extension of Approval (EOA) issued by AICTE ref.(2) (Pls see Annexure-II). Our Computer Science Engg.-UG branch of our Institute is Accredited by NBA and the increase in Intake has been approved from 120 to 180 by AICTE in the EOA dtd., 30/04//2019.

Considering the above fact it should be clarified that the Computer Science Engg-UG branch Intake of our Institute should be 180.



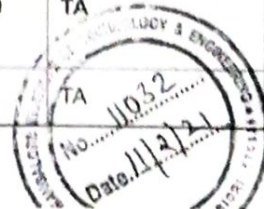
