To ensure a conducive academic atmosphere for newly enrolled students in college and hostel premises, various measures were discussed during Anti-Ragging Committee meetings held on the following dates:

Based on the discussions in the meetings held on the mentioned dates, the following measures have been implemented:

• Formation of Vigilance Teams

Separate vigilance teams consisting of faculty members were formed alongside the Anti-Ragging Squad. These teams made scheduled visits to various locations, such as the food court during tea and lunch breaks, parking lots, college buses, the area outside the main entrance, and both boys' and girls' hostels. The vigilance teams documented their observations in log registers stationed at each of these stations. Details of the vigilance team visits are as follows:

Presentation on Awareness on Legal Consequences of Ragging

- For Senior Students: Heads of Departments and faculty highlighted the definition and forms of ragging, its legal consequences, the composition of the Anti-Ragging Committee and Squad, the requirement to file online affidavits, and the mechanisms available for reporting grievances.
- For First-Year Students: The Convener of the Anti-Ragging Committee delivered detailed sessions on institutional policies, legal implications, reporting systems, and the institution's strict stance against ragging to ensure a safe and inclusive environment.
- Poster Presentation Competition: With the theme "Say No to Ragging", 15 groups from senior batches participated, presenting posters on the legal repercussions of ragging, empathy, and peer respect.

- Nodal Officer Appointment: Mr. Surjit Ram, Senior Assistant Professor, Dept. of Humanities, was appointed as the Nodal Officer for Anti-Ragging matters for AY 2024–25.
- Monitoring During Bus Commute: Faculty members traveling in buses monitored student interactions and recorded observations in registers. Specific seating arrangements were enforced: first-year students in front, faculty in the middle, seniors at the back to ensure a safe commute.

• Regular Preventive Measures

Separate mess timings for first-year students.

Segregated hostel blocks for juniors and seniors.

CCTV surveillance in vital areas.

Wardens regularly monitored dining halls to ensure safety and comfort.

- Extended Vigilance Beyond Campus: Details of students staying in private/government hostels and PGs were shared with local police. Police officials conducted periodic visits in coordination with the vigilance team.
- Involvement of Non-Teaching Staff: Food court staff was sensitized on their role in vigilance. They were instructed to remain alert during peak hours and report any suspicious activity immediately.

• **Student Feedback Mechanism:** Structured feedback was collected from first-year students every semester. Feedback covered the effectiveness of the Anti-Ragging Squad, vigilance teams, and overall institutional measures.

Outcome: 94% of students rated the anti-ragging initiatives as "Very Good".
